NARCOTICS FIEND BUSTED!

SFPD ARREST ARMED SUSPECT DEALING NARCOTICS IN SAN FRANCISCO

SAN FRANCISCO—On Tuesday, October 15, the San Francisco District Attorney's Office indicated in a press release that German Alfred Colindres-Estrada, 24, of Oakland, and Jose Colindres-Erazo, 22, of Oakland, have been charged with multiple felonies in connection with the alleged possession and sale of controlled substances.

Colindres-Estrada was arraigned on October 11, and pleaded not guilty to all charges and denied all allegations. He is scheduled to be arraigned on October 16, at 9 a.m. in Department 10 at the Hall of Justice.

Both suspects are charged with three counts of possession for sale of controlled substances (H&S 11351), one count of possession for sale of cocaine base (H&S1151.5) one count of possession for sale of methamphetamine (H&S 11378), four counts of transportation, sale and giving away of controlled substances (H&S 11352(a)), one count of transportation, sale and giving away a controlled substance (H&S 11379(a)), and three counts of possession of a controlled substance with a firearm (H&S 11370.1(a)). The criminal complaint also alleges that they were each armed with a semi-automatic pistol in the commission of these crimes as well as numerous other allegations.

Colindres-Estrada is also charged with several additional felony counts including possession of a firearm by

a felon (PC 29800(a)(1), carrying a loaded firearm (PC 25850(a)), and one count of possession of a concealed firearm in a vehicle (PC 25400(a)(1)) one count of possession of ammunition by a prohibited person (PC 30305(a)), two counts of possession for sale of fentanyl (H&S 11351), one count of possession for sale of methamphetamine (H&S 11378), one count of possession for sale of cocaine base and one count of maintaining a place for selling or using controlled substances (H&S 11366).

He is also charged with one count of carrying a loaded firearm (PC

25850(a)) and one count of concealed firearm in a vehicle (PC 25400(a)(1)).

According to court documents, on October 8, at 11:24 p.m. both suspects allegedly drove to San Francisco from Oakland in Colindres-Estrada's vehicle. They allegedly parked on 11th Street between Kissling Street and Howard Street. Allegedly they were each carrying a backpack. The San Francisco Police Department K-9, Cooper alerted officers to the presence of narcotics in Colindres-Erazo's backpack.

Officers found cocaine base, heroin, methamphetamine, fentanyl, cash,

and a digital scale in his backpack. Officers searched the vehicle and found a loaded 9mm semi-automatic pistol in the center console and another digital scale. Officers executed a search warrant at Colindres-Estrada's residence in Oakland and seized methamphetamine, fentanyl, cocaine base, cocaine, a large amount of cash, firearm parts, numerous rounds of ammunition, and multiple disassembled firearms and rifles.

Total weight of narcotics seized: 620.7 grams (more than one pound) of fentanyl, 347.4 grams of methamphetamine (more than half a pound), 69.9 grams of cocaine base, 94.1 grams of cocaine, 8.4 grams of heroin and \$45,078 in cash. At the time of his arrest, Colindres-Estrada was on felony probation following a 2023 conviction.

The next court date for Colindres-Estrada is October 24, for the preliminary hearing in the case. The SF District Attorney's Office moved to have each detained pending trial because of the public safety risk they pose. The court granted the motion and set no bail. Both defendants are currently in custody.

JAHAD ANTOINE ARRESTED FOR ASSAULTING SENIOR CITIZENS

SAN FRANCISCO—On October 16, the San Francisco Police Department announced in a news release that they arrested a suspect involved in two separate violent attacks on senior citizens, including a 90-year-old man and a disabled man, Police Chief Bill Scott announced.

"These callous attacks on our most vulnerable community members are unconscionable," said Chief Scott. "Thankfully our officers were able to identify the suspect and make a swift arrest. These kinds of attacks will never be tolerated in San Francisco, and we will do everything within our

power to bring the victims justice in these cases."

On October 15 at approximately 10:19 a.m. the suspect charged and attacked the elderly victim on a Muni bus in the areas of Bryant and 3rd Streets. The suspect struck the victim multiple times in the head and kicked the victim after he fell to the ground.

The suspect fled the scene before police and paramedics arrived and treated the victim. The victim was taken to a nearby hospital where he is being treated for life-threatening injuries. Officers collected evidence at the scene, including video surveillance.

In a second incident, at approximately 12:30 p.m., several witnesses reported a suspect shoved a 68-year-old man, who uses a walker, to the ground at Cyril Magnin and Eddy Street at Hallidae Plaza. The victim struck his head on the ground and was transported to the hospital with non-life-threatening injuries.

Antoine was booked in San Francisco County jail for resisting or delaying arrest (148(a)(1) PC), elder abuse (368(b)(1) PC), assault likely to produce great bodily injury (245(a)(4) PC) and numerous warrant violations.

Officers determined Antoine was the same suspect in the earlier assault on Muni and booked him on additional charges of assault with a deadly weapon likely to produce great bodily injury (245.2 PC), battery against an operator, driver or passenger on a bus (243.3), elder abuse (368(b)(1)PC), inflicting great bodily injury on a person who is 70 years of age or older (12022.7(c) PC).
